# **Library Services Contract**

Parties to this Contract: This agreement is made between the Henry D. Moore Parish House and Library, located at 22 Village Road in Steuben, ME, and Regional School Unit 24.

Location of Services Provided: All services referred to in this contract are to be provided at the Henry D. Moore Parish House and Library building in Steuben, located across Village Road from the Ella Lewis School.

### **Specifications of Contracted Services:**

The Henry D. Moore Parish House and Library shall make its library and community center facilities available to the staff and students of the Ella Lewis School for the 2017–2018 school year. This service includes hosting regular class visits to the library with complete book-borrowing, reference material and technology-use privileges, and extensive librarian assistance, as well as accommodating special events (art shows, performances, after-school activities, teacher meetings and staff trainings, etc.) when scheduled in advance. Inter-library loan request costs are covered by this contract, but fees for making copies of, printing, and scanning documents are separate charges to be covered by the individuals using these services.

Indemnification and Insurance: The RSU shall indemnify and hold the Henry D. Moore Library and Parish House harmless for liability for any bodily injury, property damage, or other claims or demands of third parties resulting from the services provided to Ella Lewis School students and staff during school hours and during school-sponsored events. Individual students and staff shall be responsible for covering the cost of lost or damaged borrowed books. The RSU shall obtain and maintain general commercial liability coverage in an amount no less than \$300,000 aggregate single liability for bodily injury, death, and property damage for this purpose.

Cooperation: The Parish House Board and Staff shall cooperate with the staff of the Ella Lewis School to facilitate scheduling of class visits and other uses. The librarian of the Henry D. Moore Library shall assist teachers in making class visits to the library pleasant and effective learning experiences

Contract Price: The aforementioned services shall be provided in exchange for a total payment of \$5,000.

#### Dear David.

Please find enclosed a contract for library services for the Ella Lewis School for the 2017/2018 school year for which we are requesting reimbursement. Note that in order to help cover our expenses, which increase with inflation each year and which will be increasing more significantly this year as we are hiring a part-time assistant Library director tasked specifically with focusing on children's activities and programs at the library, we are asking for \$5000. This is the first such increase in all the years we have contracted with the RSU, and the additional staff will allow us to provide a higher quality of service to the Ella Lewis Students. The other contract terms are identical to those of the past several years.
